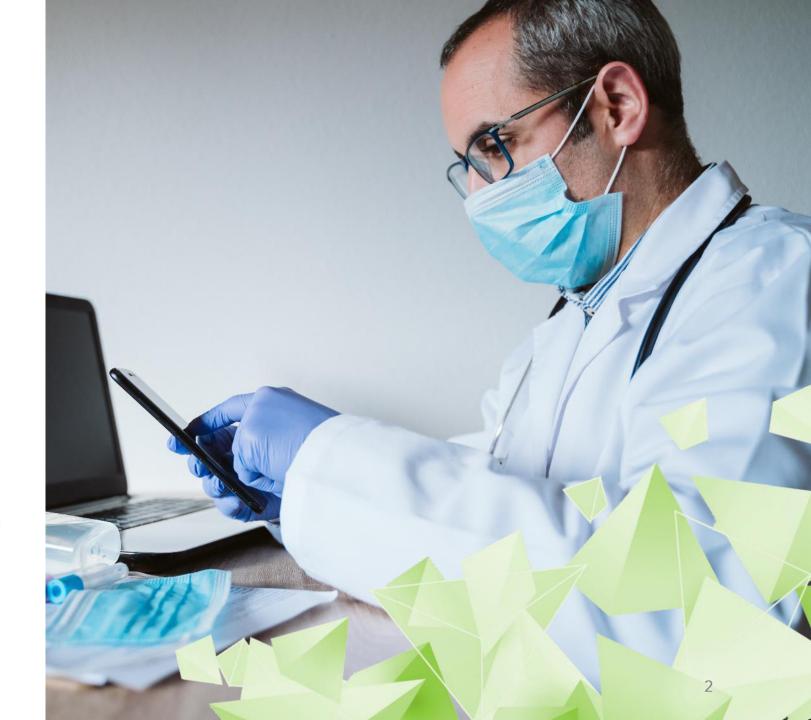


### Physician Responsibility

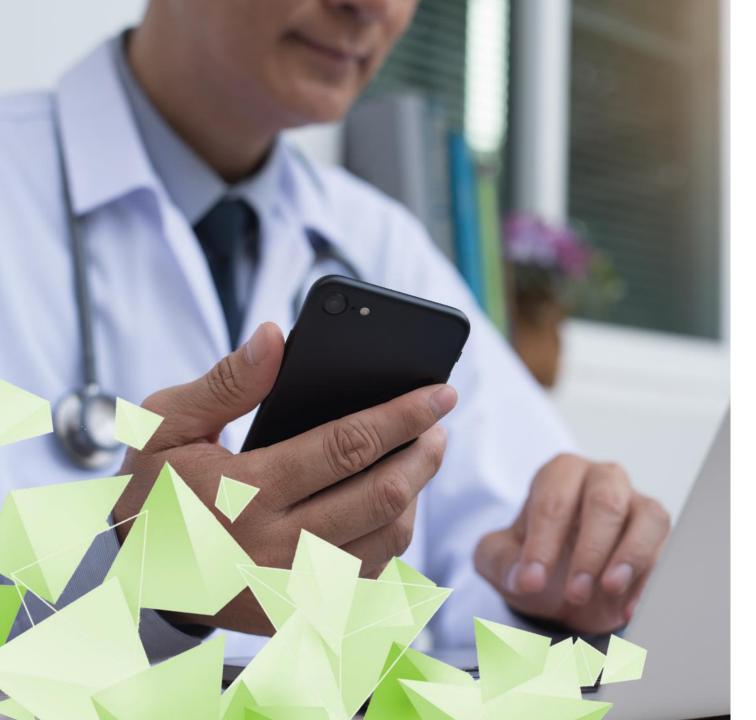

## More Context Via Secure File Sharing

Exchanging protected health information (PHI) via pagers is insecure. Patient information can be accessed by unauthorized third parties, defrauding patients in the process.

### Full Visibility Into Colleague Presence Statuses

OnPage visually represents which care team members are "online," "offline" and on "Do-Not-Page" mode. Presence statuses keep physicians informed on who is available during critical situations. This not only makes team collaboration easy, but it also ensures accountability because users can see that the physician being alerted is online and should be available for a response.



#### OnPage Presence Statuses

Colleague presence statuses are readily available on the OnPage web management console and mobile app. Statuses are colorcoded, indicating a physician's availability. Codes are as follows:

Green icon: User is logged in and available for messaging and

alerting

Red icon: User is signed out and unavailable

Yellow icon: User is signed in, but their pager is off

Black icon: Group icon
